## DEFINITIONS

Voyages generally include all trips on water (e.g. cruises, river cruises, sailing trips, yacht charters). The special premium for voyages applies here.

The following trips are excluded: "Blue trip" in Turkey and cruises on the Nile in tour operator catalogues, ferry crossings and houseboats. In these cases, the premiums for flights apply.

Combined trips must also be insured as voyages if the proportion of the voyage makes up more than $1 / 3$ of the total duration of the trip (e.g. 1week cruise, 1 -week stay at a hotel).

A family is classed as comprising a maximum of 2 adults accompanied by at least 1 travelling child under the age of 21 (up to 21st birthday) (regardless of family relationship) - up to 7 people in total.

Information: The family premium does not apply to 2 adults without children.

If more than 6 persons (for family premiums: more than 2 families) have booked and insured a trip together, only the relatives of the insured person and their companions shall apply as risk persons, not all insured persons among one another.

A closed travel group consists of at least 10 individuals, or at least 6 individuals for train journeys at the same time and with the same destination. If the travel group has a guide (e.g. a teacher, parent, skipper), the tour guide must also be insured if no replacement can be found.

Last-minute tariffs can only be used for bookings made up to 30 days ( 30 to 0 days) before the start of the trip.

## Insured persons are:

- insured persons who have booked and insured a trip together between one another.
- the relatives of an insured person; these shall include spouses or civil partners, children, parents, adopted children, adoptive parents, foster children, foster parents, step-children, step-parents, grandparents, siblings, grandchildren, parents-in-law, children-in-law and siblings-in-law, aunts, uncles, nephews and nieces.
- persons that are looking after minor-age or care-dependent relatives of an insured person that are not on the trip.
